- 1. The University of Nebraska, Center for Global Health and Development, (CGHAD) (located in 984585 Nebraska Medical Center, Omaha, NE 68198-4385) College of Public Health, and Institute of Public Health, Hacettepe University (located in Hacettepe Üniversitesi Halk Sağlığı Enstitüsü, Sıhhıye Yerleşkesi, Halk Sağlığı Enstitü Binası, 3. Kat Sıhhiye 06100 Ankara) desiring to promote cooperation in the fields of education and academic research, in line with the Memorandum of Understanding signed between the two Universities, agree to the following:
 - 1.1 to encourage exchanges and visits in the following categories: graduate (contingent upon UNMC and HU regulations) and professional students, non-teaching and post-graduate fellows, and junior and senior faculty members.
 - 1.2 to exchange information and materials in those fields which are of interest to both universities.
 - 1.3 to organize joint conferences and academic programs.
 - 1.4 to arrange joint research activities and publications.
- 2. Subject, implementation and administration of aforementioned cooperation will be ensured by separate protocols which would be structured by contracting parties.
- 3. This Agreement will be in effect from the date of signature for a period of five years. It shall be extended automatically for an additional period of five years at each expiration date unless either party gives six months' advance notice in writing to terminate the Agreement.
